<u>Client Conduct</u>

Clients are expected to conduct themselves in a respectful and sportsmanlike manner during all coaching sessions, games, and other program activities. We reserve the right to dismiss any client whose behavior is disruptive or disrespectful.

Liability Waiver

By participating in our programs, you acknowledge and assume all risks associated with football participation, including but not limited to injury. You agree to hold harmless New Wave Football and its coaches from any liability arising from participation in our programs.

Medical Disclosure

Clients are required to disclose any pre-existing medical conditions that could impact their participation in our programs.

Photo & Video Release Consent

New Wave Football (the "Business") respects the privacy of its players and their families. This Photo and Video Release Consent Policy (the "Policy") outlines how the Business obtains consent to use photographs and video recordings of players participating in the Business's programs (the "Images").

By registering a player for a program offered by the Business, the player's parent or legal guardian (the "Guardian") agrees to the terms of this Policy.

The Business may use Images of players for the following purposes:

• On the Business's website and social media platforms to promote the Business's programs and activities.

• In Business newsletters and marketing materials.

The Business will not use images of any player in a way that is

disrespectful, discriminatory, or otherwise harmful.

The Guardian grants the Business a non-exclusive, worldwide, royalty-free license to use the images for the purposes described above. This license will continue indefinitely unless revoked by the Guardian in writing.

The Guardian has the right to revoke consent at any time by submitting a written request to the Business. The Business will make reasonable efforts to remove the Images from its website and social media platforms within a commercially reasonable time after receiving a written revocation of consent. However, the Business may not be able to remove Images from all materials where they have already been distributed.

The Business is committed to protecting the privacy of children. In some cases, the Business may obtain a separate consent form from a player who is 18 years of age or older.

To opt out of giving consent to this policy, please check the box indicating this decision when booking or by contacting and informing the business in writing.

Termination

We reserve the right to terminate your enrollment in a program for any reason, including but not limited to non-payment, behavioral issues, or violation of these terms and conditions.

Governing Law

These terms and conditions will be governed by and construed in accordance with the laws of Victoria, Australia.

Entire Agreement

These terms and conditions constitute the entire agreement between you and New Wave Football, regarding the football coaching services provided.
